A Legacy of Helping Friends and Neighbors at Scotia Village

Miss Carter made charitable gifts to the Foundation throughout her lifetime, and in 1996 made the decision to include the Foundation in her estate plans, joining Scotia's Hix Society.

Miss Carter, was born April 8, 1931, to Henry F. and Kate C. Carter. Growing up in Maxton, she graduated from Maxton High School in 1949 and was second in her class. After graduating from Duke University in 1953, she began her career as an elementary school teacher. She taught in several locations in Winston-Salem and Charlotte before coming back to teach in

Maxton, where in addition to teaching in the public schools, she also taught Sunday School at St. Paul's United Methodist Church. Katherine (better known as Miss Carter) taught for 35 years and was beloved by her students. She enjoyed seeing them in the community and following their successes. She was a gifted and excellent teacher who had her students' best interests at heart.

Katherine had various interests and had traveled extensively, but her love of Maxton and St. Paul's United Methodist Church always shined through. She was a loyal, dedicated citizen and had many friends. She was always pleased to meet or see people with Maxton roots and often enjoyed taking a photograph of her guests when possible, to commemorate the visit. She joined some of her close Maxton friends when she moved to Scotia and continued to make new friends as well. She was an avid Duke Blue Devil basketball fan and enjoyed talking about the team with others.
